Additional legal rights for consumers.

The rights conveyed under this Voluntary Warranty are in addition to all rights and remedies provided by consumer protection laws in the country of purchase.

What this Voluntary Warranty covers?

The SCEN S.r.l. entity listed under the heading of ‘Designer and manufacturer’, will at its option (but without affecting your statutory rights), repair or replace any components of the LETIsmart LUCE device which are defective in terms of material or workmanship when used in accordance with the LETIsmart LUCE User Guide and which are subject to a valid Voluntary Warranty claim. The provisions of this Voluntary Warranty are only valid in the country of purchase.

Duration of this Voluntary Warranty.

The duration of this Voluntary Warranty for the individual components of the LETIsmart LUCE system is as follows:

Device: Two years from the date of purchase.

What is excluded from this Voluntary Warranty?

The following are excluded from the terms of this Voluntary Warranty:

- a) Damage to any of the LETIsmart LUCE components caused by normal wear and tear;
- b) Cosmetic damage (such as scratches, dents and breakage of the device and the mechanical parts);
- c) Damage to the LETIsmart LUCE system components caused by misuse, power surge, improper handling, liquid contact, fire or removal of serial number;
- d) Malfunction due to use with non-compatible product;
- e) Damage or malfunction caused by installation, attempt to open, modify and repair a LETIsmart LUCE system components, either by a user or by a technical service provider not accredited by the manufacturer;
- f) Damage or malfunction caused by failure to use as described in the LETIsmart LUCE User Guide;
- g) Malfunction of the battery;

To make a warranty claim under this Voluntary Warranty, you should call your Customer Care Center, providing a description of the problem, a proof of purchase and the Serial No. indicated above the label under the device’s battery.
